**Item 1. Security and Issuer.**

The class of equity securities to which this statement relates is the common stock, par value \$.01 per share (the "Common Stock"), of Harris & Harris Group, Inc., a New York Corporation (the "Company"). - (d) Neither of the Reporting Parties has during the last five years been convicted in a criminal proceeding.
- (e) The Reporting Parties have not been and are not subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violations with respect to such laws.
- (f) The Reporting Parties are husband and wife and are citizens of the United States of America.

**Item 3. Source and Amount of Funds or Other Consideration.**

**Item 4. Purpose of Transaction.**

On May 14, 2009, Susan T. Harris transferred to Charles E. Harris, by means of a bona fide gift, 1,039,559 shares of the Company Common Stock which she directly owned. As a result, Charles E. Harris now owns 2,239,752 shares of the Company's Common Stock directly. Indirect beneficial ownership of Mr. Harris's 2,239,752 shares may be attributed to Mrs. Harris. The aggregate amount of the Company's Common Stock beneficially owned by Mr. and Mrs. Harris has not changed as a result of Mrs. Harris' gift to Mr. Harris.
